Mr. DeColfmacker led those present in the flag salute at 6:00.

Mr. DeColfmacker opened the Public Hearing at 6:00.

Mrs. Lambert included the Special Ed Expenditure Report in the Board packets which show a negative of \$616,280. There may be some encumbered things but not much. Students coming in requiring special services such as a student who came here in July that cost the district \$120,000. There was also another student with special needs that came in. Special Ed Transportation was another unexpected expense. Mrs. Lambert said that the last payroll run is next week as they are closing out early because they are moving to a new system but those lines are already over because we hired people with more experience.

No funds are able to be expended from the Transportation Fund because it is only to purchase buses. As of today, there is \$214,855 in the Special Ed Trust Fund. We are asking the Board to approve withdrawing \$214,800 from that fund. \$50,000 will go into that fund in July. Mrs. Lambert said she was able to find two invoices that have been paid in the amount of \$2,292.50 that can possibly come out of the Updating and Improving Security Trust Fund. That would be the decision of the Trustees.
